Minutes of an Extraordinary Meeting of the Full Council held on Wednesday, 12th June 2024, at 7.30 pm, in the Main Hall of the Imperial Hall, Chapel Street, Epworth

Public Participation

Proposed by Councillor Finch and seconded by Councillor Holt - It was resolved that the public participation time be allowed to be more than the usual 15 minutes to allow all members of the public to speak.

Several members of the public had expressed a wish to address Full Council about PA/2024/513.

Some members of the public expressed the following comments in support of the planning application:-

- Everyone wants a better surgery
- Provide 21st century practice as the current building is outdated and not fit for purpose
 with only two parking spaces. No disabled access so doctors have to come downstairs
 to patients, limited room space to fit all of the b staff in the building with doctors
 working remotely, desperate for room space to provide better offices and new services
 nearer to home. NHS is supportive but it does not have the money to provide a new
 surgery
- Number of over 65s has increased by 26% and the trend is set to continue, so need to increase capacity with more rooms
- A larger building will be future proof, and if you can future proof it, this can benefit everyone not just Epworth residents
- Garden centre dilapidated built in 1960s / 1970s
- A supermarket will avoid a 24 mile round trip / cost of it being delivered
- Availability of car parking
- Public right of way may be enhanced
- Drainage flood authority not objecting
- New tanks underground
- Bypass sewers on Belton Road
- Biodiversity 5% gain above national average
- No evidence of environmental harm
- Taken 'stuff' out of the conservation area
- Historic England not objecting, seen visual info, site sits in a hollow
- Not about here and now, but the future
- £9 million turnover to town

- Does not conform to the Local Plan
- Outside the development limit
- Contravenes planning policy
- · Contradictory documents submitted
- Development may take away rural heritage
- Architectural style not in keeping
- Ill conceived car parking layout

- Increase traffic congestion will back up along the hazardous A161
- Pedestrian access concerns due to narrow pavements
- No link with the centre of Epworth
- Flooding concerns pipes in state of collapse
- Suffering from sewage discharges from manhole covers
- Water in houses on Battle Green / West End Road
- Medical centre is not a gift to the community if leased
- If no pharmacy on the site of new medical centre will still have to go up to Weldricks
- Not future proof i.e. needs to incorporate a chemist / chiropody etc, soon be out of date
- A supermarket is no cheaper still need to travel
- A supermarket trading will impact on butchers, grocers etc.
- A supermarket will attract shoplifters
- A supermarket will lead to the death of the town
- Noise & air pollution
- Development at back of house increase in cars going past front & back and deliveries
- Diminish value of property
- Setting precedent for future applications
- · Land is a Church Field
- Nothing to draw people in need more
